"This Agreement is make on the 10<sup>th</sup> day of September 2012 and effective from retrospect date of 1st day September of 2013 between Aniceto School, Manuel Llaneza, n°1, through its Principal (hereinafter to the referred as "School" or "Management"), hereinafter called the First Party of the first part.

#### AND

Sh. Prateek Kumar S/o Juan González Padilla hereinafter called the Second Party of the other party.

The term, First Party unless repugnant to the context hereunder given shall be deemed to include their legal heirs, representative, successors-in-interest, administrators and assigns.

#### A. DESIGNATION

The Second Party is appointed as Spanish Faculty in the School.

#### B. PAY

The average teaching load per day of the Second Party is expected to be from 8:30 am- 13:30pm in winter and from 8:00 am to 13:00 pm in summer from Monday to Saturday. The Second Party shall be paid a gross remuneration of Rs 15,000 per month. Any charges in remuneration whatsoever will be only made by mutual agreement and contract revision.

The gross remuneration during the fixed term of this contract is subject to deduction of tax at source in accordance with applicable laws and regulations in India.

The Second Party shall be eligible to avail accommodation provided by the School as per the rules of the School. This contract shall not entitle the First Party to any medical benefits extended on behalf of the School.

The Second Party shall be eligible to ten (10) working day paid leave per year, including three (3) as Medical Leave characteristics. For this matter, the Second party is required to take prior approval from the management. The leave shall accrue on your account on the completion of the year. These leaves, however, will not be encashable.

### C. INCREMENT

In case of annual increment of the Second Party, it will be determined on the basis of the performance, efficiency and satisfactory discharge of duties by the Second Party...."

The gross remuneration during the fixed term of this contract is subject to deduction of tax at source in accordance with applicable laws and regulations in India.
